course fee for discovery program

22301VIC Certificate I in Transition Education (Discovery)

Students who participate in Inclusion Training's Discovery Program and who are enrolled in 22301VIC Certificate I in Transition Education incur a course fee that combines the tuition fee and amenities costs.

- ▶ The invoiced tuition fee includes days in which a student may be absent.
- ▶ At time of printing, learners enrolled in an accredited education program who meet the minimum study requirements are entitled to receive the Pensioner Educational Supplement (approx. \$30 per week).
- ▶ Costs for each individual unit are available on the Inclusion Training website.

This fee is a personal contribution from the student and cannot be charged to a funded support package. It can be paid via Direct Debit or Centrepay.

As of 1 July 2008, the board of Inclusion Melbourne undertook to maintain a reduced level of funding for long-term students (Legacy) and students holding a Concession Card who had been enrolled in pre-accredited training prior to this date.
